After a program has begun, a prorated refund/credit is only issued in the event of a medical reason with a doctor's note.

Waiver, Release of Liability and Indemnification:

- Obligation to Inspect Facility/Equipment and Report Unsafe Conditions: The undersigned agrees to prior
 participation, he/she will inspect facilities and equipment to be used, and if he/she believes anything is
 unsafe, will immediately advise a TSA representative of such conditions and suspend participation until
 perceived safety issue is satisfactorily resolved.
- 2. **Recognition of Inherent Risks**: The undersigned acknowledges and fully understands that in utilizing the facilities on or off-site, he/she may engage in activities that involve inherent risk, including, but not limited to: i) use of excessive weights or resistance, ii) failure to properly execute exercises or fitness drills, iii) tripping or falling during exercise activities; iv) falling off exercise equipment; v) contact with other participants utilizing the facilities, whether or not engaged in the same activities as the undersigned; vi)

collisions with walls, columns or other fixed objects or equipment located both within and outside the facilities; and vii) being struck by balls, bats or other equipment utilized in the activities. The inherent risks may result in serious injury, including permanent disability and death, any sever social and economic losses which might result from the undersigned's own actions or inactions or from the negligence or intentional acts of others, the rules of play or the conditions of the premises, equipment used or their participation in any of our activities, programs or special events. The undersigned also acknowledges that there may be risks not known to TSA.

- 3. **Assumption of Liability for Inherent Risks**: The undersigned assumes all the foregoing inherent risks and accepts personal responsibility for any and all damaged arising from any injury, permanent disability of death which results from the inherent risks or other risks beyond control of TSA.
- 4. **Release and Covenant Not to Sue**: The undersigned herby releases and covenants not to sue TSA, its owners, shareholders, directors, coaches, employees, representatives, agents, and lessees from any and all claims resulting from: i) the inherent risks of use of the facilities and equipment of TSA, including but not limited to any loss, injury, damage to self or property or liability sustained while on or about the premises of TSA or participating in any of our programs on or off-site.
- 5. **Indemnification**: The undersigned shall defend, indemnify, and hold TSA, its officers, employees, and agents harmless from and against any and all liability, loss, expense, including reasonable attorney's fees, claims from injury or damages to the extent that the same are caused by or result from the negligence or the intentional acts or omissions of third parties or of an individual or group renting space from the facility, its officers, agents or employees.

The undersigned has read, understood this waiver and release and indemnify form, and acknowledges that he/she is freely entering into the above waiver and release, understanding that he/she has given substantial rights by signing it and is, nonetheless signing voluntarily under no duress or time constraints. The undersigned has been given an opportunity to speak with a representative of TSA to discuss any questions he/she might have. Without limiting the generality of the foregoing it is the undersigned's intention on his or her own behalf, and/or on behalf of his/her minor child to specifically release and indemnify TSA from any liabilities, losses, damages, settlements, claims, expenses and costs arising from his/her child's participation in the desired activity described in the preceding paragraphs, said indemnity to include reimbursement of TSA court costs and reasonable attorney's fees.
